**VERIFIED PETITION FOR SPECIALIZED DRIVING PRIVILEGES**

Defendant, **Defendant Name**, by counsel **Attorney Name**, petitions the Court to grant the Defendant Specialized Driving Privileges, and in support thereof alleges:

1. Defendant is a resident of **name** County, Indiana, Defendant’s address is: **address, city, IN #####.**

  - b. To maintain proof of future financial responsibility as required by Indiana law at all times during the period of the specialized driving privileges ordered by the Court;
  - c. To carry a copy of the specialized driving privileges order on Defendant's person or have it in the vehicle which she is driving;
  - d. To produce a copy of the specialized driving privilege order to a police officer upon request.

Wherefore Counsel for Defendant petitions the Court to issue the Defendant Specialized Driving Privileges subject to such conditions as the Court, in its discretion, deems appropriate.

**ORDER GRANTING SPECIALIZED DRIVING PRIVILEGES**

The Court, being duly advised, now finds:

1. That Defendant is eligible for specialized driving privileges pursuant to I.C. 9-30-16;
2. That this Court has the jurisdiction to grant specialized driving privileges to Defendant; and
3. That Defendant should be granted specialized driving privileges subject to the conditions specified below.

It is, therefore, ordered by this Court:

1. That the suspension of driving privileges **ordered by this Court as part of the sentence in this case OR ordered by the BMV (Suspension #)** be stayed for **180 days**;
2. That Defendant be granted specialized driving privileges on the following conditions:
  - a. **[optional]** Defendant may operate a vehicle to and from, and during the course of, **(reasons)**.

- b. **[optional]** Defendant may only operate a vehicle **between the hours of \_\_\_\_\_ am/pm and \_\_\_\_\_ am/pm.**
- c. **[optional]** Defendant may only operate a vehicle in the following locations: **[ex: Monroe County/State of Indiana/etc.].**

3. That Defendant shall:

- a. Maintain proof of financial responsibility (insurance) at all times during the above-specified period of time during which these specialized driving privileges have been granted;
- b. Carry a copy of the this order on his/her person or have the order in any vehicle that he/she operates; and
- c. Produce this order to any police officer upon that officer's request.
- d. Carry photo identification on his/her person;
